4) Net liaison Station: between Regional Net 146.94 (88.5) and Northland ARES voice and digital nets.

5) Participating members complete the Survey Monkey
Operate a Hot Wash Net for all members to comment on the event
NCS will advise operators after End-X
AAR will be conducted during the October NLARES Monthly meeting.


